On August 10, 2012 at approximately 11:30AM Fayette County Sheriff's Office Investigator's began investigating a murder which occurred in north Fayette County at a residence on Bohannon Road.

The victim, Donna Denice Roberts, 44, lived at the home on Bohannon Road with her 78 year old grandmother due to the fact that Ms. Roberts was both physically and mentally handicapped and required constant care.

Ms. Roberts left the residence with her grandmother earlier that morning to run errands locally. When the women returned to the home they entered the front door and encountered an unknown number of suspects burglarizing the residence. The women immediately exited the home's front door upon discovering the criminal act in progress. It is believed the suspect(s) also exited the residence using a rear door and fled to an awaiting vehicle. The suspect vehicle is being described as a possible four (4) door grey or silver passenger car.

As the suspect(s) fled from the incident location at least one (1) shot was fired striking Ms. Roberts where she was later pronounced deceased at the scene. The 78 year old woman was not injured in this incident and was later released to family members.

Fayette County Investigator's are urging anyone with information in this case to please contact the Fayette County Sheriff's Office. A reward is being offered for information which leads to the arrest(s) and conviction of the suspect(s) in this case.

Victim Denice Roberts

On August 10, 2012 at approximately 11:30AM Donna Denice Roberts was murdered at her home on Bohannon Road in Fayette County. Ms. Roberts was disabled and was cared for by her 78 year old grandmother. Both women left the residence earlier that morning to run errands. When the women returned to the home they encountered an unknown number of suspects burglarizing the residence. The perpetrators fled to a waiting vehicle. The suspect vehicle is described as a light colored 4 door passenger car; possibly light gray.

Fayette County Investigators are asking for anyone with information on this case to please contact the Fayette County Sheriff's Office. A reward is being offered in this case for information leading to the arrest and conviction of the suspect(s) in this case.
