Fayette County Sheriff's Office Investigators made an arrest on February 24, 2012 in connection with a burglary which occurred earlier that day. Investigators have arrested David Anthony Sharp, 37, of Newnan charging him with Burglary.

This case involves Sharp entering into a residence on Lee's Lake Road in north Fayette County with the intentions of stealing items inside.

Fayette County Sheriff's Office Investigators made an arrest on February 24, 2012 in connection with a burglary case which occurred between the dates of December 17-23, 2011. Investigators have arrested Lucas W. Baucom, 18, of Griffin charging him with Burglary and Theft by Taking.

This case involves Baucom entering into a residential garage on Carrington Lane in south Fayette County with the intentions of stealing items inside. Baucom also went on to the premises of a second residence on Carrington Lane stealing some personal property belonging to the Fayette County victim.

Fayette County Sheriff's Office Tactical Narcotics Team (TNT) Investigators made two (2) arrests on February 29, 2012 in connection with a buy bust operation which occurred earlier that day. TNT Investigators have arrested Keith McCullum, 18, and Jerry McCullum, 24, both of Riverdale and both being charged with Possession of Marijuana with Intent to Distribute and Possession of Cocaine with Intent to Distribute. Keith McCullum was also charged with Sale of Marijuana.

This case took place on Hwy 92 North in north Fayette County when Keith and Jerry McCullum exchanged with the intentions to sale approximately ¼ pound of marijuana to an undercover TNT investigator. Both suspects were arrested after the transaction took place and were additionally found to be in possession of cocaine.

Fayette County Sheriff's Office Tactical Narcotics Team (TNT) Investigators made an arrest on February 27, 2012 in connection with a buy bust operation which occurred earlier that day. TNT Investigators have arrested Mathew Gates, 26, of Newnan and charged him with Sale of Marijuana and Sale of a Schedule IV Narcotic.

This case took place on Hwy 74 in north Fayette County when Gates exchanged with the intentions to sale approximately ¼ pound of marijuana and a schedule IV narcotic (Xanax pills) to an undercover TNT investigator for approximately \$320.00. Gates was arrested after the transaction took place and transported to the Fayette County Jail.

Fayette County Sheriff's Office Tactical Narcotics Team (TNT) Investigators made an arrest on February 16, 2012 in connection with a buy bust operation which occurred earlier that day. TNT Investigators have arrested Ryne M. Fulton, 27, of Senoia and charged him with Sale of a Schedule II Narcotic, Possession of a Schedule II Narcotic, and Possession of a Schedule IV Narcotic.

This case took place on Hwy 74 in north Fayette County when Fulton exchanged with the intentions to sale a schedule II narcotic (Oxycodone pills) to an undercover TNT investigator. Fulton was arrested after the transaction took place and was additionally found to be in possession of a schedule IV narcotic (Xanax pills).

On January 22, 2012 Fayette County deputies responded to two (2) separate residential burglaries in the southern portion of the County. One of the burglaries had several items taken to include a heart shaped urn which contained the ashes of the couples' infant daughter.

On February 16, Fayette County Investigators arrested Shomari Qutrell Davis, 17, and on February 17, Investigators arrested Jawan Rashad Powell, 20, both from Clayton County in connection with these crimes. Investigators charged both men with two (2) counts of Burglary and one (1) count of Entering Auto.

On February 23<sup>rd</sup>, 2012, while attempting to serve arrest warrants on unrelated cases, Fayette County Warrant deputies were given a tip on the urn's location. The tip allowed investigators to recover the urn from a residence in Spalding County on February 24.
