Fayette County Sheriff's Office investigators obtained criminal arrests warrants on May 3 in connection with a fraud case which occurred on April 20 and April 25, 2012. Investigators have obtained warrants to arrest Robin Spratlin, 28, of Fayetteville charging him with three (3) counts of Financial Transaction Card Fraud and one (1) count of Theft by Taking.

This case involves Spratlin stealing the wallet containing \$300.00 and two (2) credit cards from a Fayette County citizen. Spratlin then used the stolen credit cards to make several unauthorized purchases.

Fayette County Sheriff's Office investigators made two (2) arrests on May 3, 2012 in connection with burglary which occurred earlier that day. Investigators have arrested Derek Alphonzo Cain, 28, of Fayetteville and Ayodele B. Butler, 41, of Atlanta and both being charged with Burglary.

This case involves Cain and Butler making unlawful entry into a residence on Gingercake Road with the intentions of stealing items from inside. The homeowner in this case called 911 when she returned home to find Cain and Butler attempting to steal a lawnmower from inside the garage. Fayette County Sheriff's Deputies responding to the home arrested the two (2) suspects at the intersection of Gingercake Road and Highway 92 North a short time after the 911 call was made by the victim.

Fayette County Sheriff's Office investigators made an arrest on April 29, 2012 in connection with a theft case which occurred on April 12, 2011. Investigators have arrested Wayland Walden, 50, of Fairburn and charged him with Theft by Taking.

This case involves Walden stealing approximately \$1,700.00 worth of construction tools and equipment from a home on Ebenezer Road. Walden fled the state after learning Fayette investigators had obtained a warrant for his arrest in this case. Walden was later arrested by a Mississippi State Trooper on a traffic stop after learning about the outstanding criminal arrest warrant.

Fayette County Sheriff's Office investigators made an arrest on May 9 in connection with an illegal dumping case which occurred on May 2, 2012. Investigators have arrested Michael B. Williams, 30, of College Park and charged him Commercial Dumping and Driving While a Habitual Violator.

This case involves Williams dumping a large amount of trash in the back yard of a residence on Hwy 314 in north Fayette County. Williams had been hired to dump the trash by a Fayette County citizen where he later discarded it behind the residence on Hwy 314 instead of taking it to a waste management center. Williams was operating a motor vehicle on a suspended license for being a habitual violator when he discarded the trash.
